Jimmy Chu is affectionately known as the "Saker Chairman", a nickname derived from his job as an engine room worker for a shipping transport company who taught work, and life at sea, hard work. "I often used to stand with the deck, looking at the water and think deeply about my life," he says. One day he left his job to start work to become an entrepreneur. In 1979, Jimmy Chu founded his first business, Fair Friend Enterprises Company.

Ten years later, the firm sold its first Taiwanese-manufactured machine tool and had a turnover of US\$30,000. By 2015, consolidated revenue of Fair Friend Group (FFG) reached 10.5 billion, and the business had a global customer base. Thanks to Jimmy's perseverance, FFG now has 100 companies in four major business fields: machine tools, precision metal parts, mold-making and green energy.

And the choice of open sea as a metaphor, "the 'Saker'" reflects the company's philosophy that the "sustainable development of enterprise relies on integrity and responsible business practices." The company's green energy division is a world leader in environmentally-friendly technologies such as the manufacture of LED lighting and the most energy-efficient used for power cells. Further R&D with the firm's partners in this area

is key to the company's future. "Through innovation and our continued efforts and contribution to green initiatives, we are able to enhance global environmental sustainability," Jimmy says.

"The goal of the entrepreneur isn't all about selling," he admits, he notes that he should have had a better knowledge of accountants when he started to assist the company's early startups. But above that, Jimmy has led FFG through a number of major business mergers and acquisitions thanks to his ability to see the strategic value of an investment and to overcome the risk. In 2015, FFG acquired MAG Group, a leading tool manufacturer based in Germany. As one of their target acquisitions in the industry, it enhanced FFG's reputation in Europe and increased its presence in the automotive sector.

FFG currently ranks as the world's third-largest machine tool group while ranked first in its precision machine systems. Jimmy's current ambition is to raise the world's target machine tool companies to the level of 75. Even on dry land, Jimmy still has an adventurous spirit.

Whatever you do, do it well.
